

April 19, 2021

The meeting was called to order by Supervisor Peterson at 6:02pm. The pledge was recited as an opening to the meeting.

Roll Call: Clark-virtual, Lutz-here, Peterson-here, Rice-here, Rigby-here.

Agenda and Minutes:

Rigby moved to accept the agenda and minutes from March, Rice seconded with the change in wording from contract with LTPOA cancelled to Contract with LTPOA rescheduled in the April minutes. Motion passed

Monthly Reports:

Fire: Total of 9 calls, 5 for the township. Alex Milliman stepped down as captain, and will remain on crew. Zach Milliman was promoted from Lieutenant position to fill and open captain's position.

The new battery-operated rescue tools are now in service.

Library: Patron count for the month 1,587, circulation 2,424. Full report on file.

Assessor: Processed and approved splits and lot line adjustments, entered building permits, updated tax program and finalized assessment roll.

Cemetery: Two burials, One full burial, One Cremation. Six burials spaces sold, three trees cleaned up after taken down, three stumps ground. Mowing has begun, winter graves have been seeded, and cleaning up old plastic flowers from the cemeteries. Bills for the month: 71.74 gas, 38.78 diesel, 363.45 alpha building center for gravel mix, 178.99 for supplies from GreenMark.

Ordinance: No report given

Treasurer: General fund- 175,824.85. Full report on file.

Clerk: Processed Voter file, 2 gov't surveys about township, special use permit-Chupp's Herb, meet with Gabridge to update QuickBooks, set a fishing tournament.

Supervisor: Worked with inspector Wickey, Assessor Brousseau, planning commission, reviewed maps and schedule for Dust control, attended webinars on alternative energy.

Monthly Bills: Lutz moved to accept monthly bills for the amount of 88,978.10 with an EFT transfer of 4,229.23. Seconded by Clark, motion passed.

Committee Reports:

Planning Commission: Discussion on special use permit on the number of dogs, also discussed Changes to Chapter 5 (future land use) in Master Plan.

Fire: Looking into the possibility of raising the doors to the building.

Old Business:

Resolution to adopt the Contract with LTPOA for funding of roads.

Peterson moved to approve the resolution to adopt the contract with the LTPOA for funding of road work. Seconded by Clark. Clark - yes, Lutz- yes, Peterson-yes, Rice- yes, Rigby - yes.

Motion carried.

New Business:

Update on SUP of Brian Kauffman and the number of dogs. Peterson moved to amend the special use permit to clarify that Kauffman can have 15 adult female dogs. Lutz seconded. Motion passed.

Dust control: Peterson moved to approve the dust control plan for 2021. Rice seconded it. Motion carried.

Citizens request for agenda items:

A citizen of the township raised the question of growing medical marijuana.

Ordinance discussion: The board discussed a number of issues about the township ordinances.

Adjournment: Rice moved to adjourn at 8:45. Peterson Seconded. Motion carried.
