Roll Call: Clark-here, Lutz-absent, Peterson-here, Rice-here, Rigby-here.

Agenda and Minutes: Clark moved to accept the agenda and minutes with corrections of Rigby be present during roll call. Rigby seconded - Motion passed.

Visitor Comments: Graig Grabal (ran for county commissioner presented a letter from Jeffery O'Donnell outlining the threats of a cyber-attack to our computers during the election. He requested that someone from the township attend a meeting outlining the procedures we should take to potential problems.

Cathy Brandon from Nottawa requested a speed study in Nottawa at the Party Store, as there is a lot of traffic congestion and with school in session children in the area. The board agreed with her, but warned her that a speed study does not always go the way you want it to go there is a potential that they may raise the speed. Another visitor on Shimmel Road across from entrance to Golf course confirmed that need to get people to stop for school buses loading and unloading.

Monthly Reports:

Fire: Calls for the month – 8 fairgrounds had 30 electrical violations; they will be working on.

Library: Circulation 766, and Upcoming programs include Fall Children's story time, fall adult craft time, fall lit loot, Take-n-make a long with teen take-n-make. full report on file.

Assessor: Processing and approving splits and lot line adjustments, processing deeds, PTA's and PRE's as necessary, entering building permits as necessary, updating tax program with latest name and address updates, meet and talk with taxpayers as needed, balance and certify warrant for summer bills, and working on land values for 2025.

Cemetery: 3 cremation or burials. New Plaque to be installed on headstone in Pioneer (celebration for Sept 28th). Bills for the month: Fuel 421.92, and Alpha building center 63.45. Tractor replaced for \$176, both mowers fixed under warranty.

New Business

River Run Point Needs Road work, bid from county to chip and seal next year is \$3781. A public hearing will be held to ask Property owners to raise yearly fee from \$25 to \$50 to defray costs. Also, they will have a new snow remover this year at a cost of \$50 each time road is plowed.

Township also needs to get bids to snow plow parking area and fill files at cemetery, in parking lot and to fill the hole on the South side of township building. Dave will check with Jay Kelley.

Peterson moved to use the grant money (12,00) to outfit the ¾ ton truck to make into a Grass fire rig. Rice seconded, approved.
