- **8.** Lake Templene Advisory Group Report Dave Young presented the report from the LTIB Advisory Committee.
 - **a.** Dredging: There are several bays around the lake with access channels that have become shallower from sediment movement, the LTIB should consider minor dredging activities to improve navigation.
 - b. BIO/Augmentation/Aeration: 1. The first Bio-Augmentation treatment was applied May 252. One small bay is being treated with double fungal and double bacteria to test formulation per suppression from LTIB April meeting.
 - **c.** New area added for bio-augmentation at area in middle of lake off Crystal Beach per approval at oct 2020 LTIB meeting.
