Lake Templene Improvement Board Meeting  
Nottawa Township Hall

1. **Call to Order** by Dave Peterson, Nottawa Twp. Supervisor, at 6:00 pm
2. **Pledge of Allegiance**
3. **Roll Call of Attendees:** Steve Wolf, present, Bob Ulrich, present, David Peterson, present, Jeffery Wenzel, present and Dennis Allen, present.
4. **Rules of Meeting-**Please turn off cell phones or take calls outside of the meeting room. Comments limited to 3 minutes
5. **Approval of today's meeting agenda and the minutes from the October 16, 2017 LTIB meeting.** The agenda and minutes were approved as written on a motion by Dennis Allen, supported by David Peterson and all other board members.
6. **Treasurer's Report-**Jeff Wenzel reported that Nottawa Township's SAD balance on November 2, 2017 is \$98,952.50 and Sherman Township's SAD balance on November 2, 2017 is \$10,206.53. The total balance available is \$109,159.03
8. **Payment of Bills-** Bills presented for payment by Jeffery Wenzel included \$10,384.50 from Spicer Group for bathymetric surveying, and \$300 from Ben Brousseau, Nottawa tax assessor, for determining the SAD lakefront property owner roll for 2018. There was discussion on paying bills in 2018 from the remaining funds in the PA 188 SADs. Lizzie Mills, attorney with Fahey, Schultz, recommends that we continue paying bills through the townships until the ~ \$100,000 carryover funds have been depleted. At that point we would begin to utilize the new Part 309 SAD funding.
9. **Lake Templene Advisory Group Report-**The bathymetric survey results comparing 2017 to 2016 look encouraging with approximately 2 million cubic feet of sediment removed. Approximately 62% of the areas with aeration/bio-augmentation saw at least 1 ½ inches of sediment reduction. We have set up a meeting for November 16 with Spicer at their Lansing office to discuss questions related to the survey. An example would be enlarging the bathymetric scanning outside of the aeration + bio-augmentation areas. We believe this skews the results. In December the advisory group will make recommendations for 2018 including the likelihood of moving at least one aeration assembly from RW2 near Bill Walters to a new location which has more bottom sediment available. On the aquatic plant contractors for 2018 we believe that both Clarke Aquatic and Aquatic Services do excellent work on herbicide application and

recommend that Paul Hausler, Progressive AE, contact both companies and solicit bids for a 3 year contract proposal. Bob Ulrich will contact Paul Hausler. In addition the committee is of the opinion that Paul Hausler be invited to submit his proposal for another year of being the weed surveyer and primary contact with the herbicide applicator. Bob Ulrich will also talk to Paul on this topic. We will need the proposals prior to the December 7 LTIB meeting. Dave Young commented that Brian Gunderson, DEQ fish specialist, has issues with our tentative plans to add a spawning bed composed of riprap/stones/gravel to the SW corner of Sauger Lake immediately adjacent to Sauger Lake Rd... More later.
