**NOTICE OF SPECIAL ASSESSMENT PUBLIC HEARING  
FOR PROPOSED RAINBOW DRIVE IMPROVEMENT  
SPECIAL ASSESSMENT DISTRICT**

PLEASE TAKE NOTICE that in accordance with PA 188 of 1954, as amended, a public hearing will be held on September 18, 2023 commencing at 6:00 p.m. at the Nottawa Township Hall, 112 S. Clark Street, Centreville, MI 49032, within the Township for the purposes of considering the proposed funding of Rainbow Drive improvements via special assessment.

PLEASE TAKE FURTHER NOTICE that the Township Board has received the plans and estimate of costs for the purposes of funding road improvements to Rainbow Drive within the Township. The Nottawa Township Board has received petitions representing more than 60% of the landowners in the proposed special assessment district and intends to proceed with such special assessment as provided in said petitions.

The road proposed for improvement is: Rainbow Drive, Nottawa Township

The proposed special assessment district consists of:

“All of those parcels with using Rainbow Drive as access from Nottawa Road to its termination point, including all of those parcels on Wright Drive and Goose Lane excepting the second and subsequent parcel under the same ownership and excepting those two parcels on the west intersection of Rainbow Drive and Nottawa Road that cannot use Rainbow Drive as access because they are water-covered at the intersection.”

PLEASE TAKE FURTHER NOTICE that at the public hearing the Township Board will consider any written objections and comments which might be filed with said Board at or prior to the time of the hearing, and any objections or comments raised at the hearing; and at the hearing (or at any adjournment of the hearing which may be made without further notice) the Township Board may revise, correct amend, or change the estimate of costs or purposes.

PLEASE TAKE FURTHER NOTICE that the plans, and costs have been provided to the Township Board are on file with the Township Clerk and can be obtained or inspected prior to or at the hearing.

PLEASE TAKE FURTHER NOTICE that if the Township Board determines to proceed with the Special Assessment District, it will cause the Special Assessment rolls to be prepared and another hearing will be held, after notice to record owners of property proposed to be specially assessed, to hear public comments concerning the proposed special assessments.

PLEASE TAKE FURTHER NOTICE that Nottawa Township will provide necessary and reasonable auxiliary aids and services to individuals with disabilities at the hearing upon reasonable notice the Nottawa Township Clerk of the need for the same. Individuals with disabilities requiring auxiliary aids or services should contact the office of the Nottawa Township Clerk at least four (4) days prior to the hearing.
